

RECLAMATION PROGRAM GUIDELINES

EcoWorx + ReWorx + Shaw Manufactured Resilient (LVT + SPC)

EcoWorx carpet tile (including EcoWorx BIO and EcoWorx M), EcoWorx Resilient, ReWorx and Shaw manufactured resilient are covered by an **Environmental Guarantee** that Shaw will transport and recycle these products at no cost to the customer in the following locations:

- **Continental U.S., Australia and Mexico locations**

The following amounts or greater are eligible under the guarantee:

- **EcoWorx Carpet Tile** 100 square yards / 83 square metres
- **EcoWorx Resilient** 1,000 square feet / 93 square metres
- **ReWorx** 500 square yards / 418 square metres
- **Shaw Manufactured Resilient** 5,000 square feet / 464 square metres

- **Canada**

The following amounts or greater are eligible under the guarantee:

- **EcoWorx Carpet Tile + ReWorx** 500 square yards / 418 square metres
- **EcoWorx Resilient + Shaw Manufactured Resilient** 5,000 square feet / 464 square metres

- **Europe and U.K. locations**

The following amounts or greater are eligible under the guarantee:

- **EcoWorx / EcoWorx S Carpet Tile** 100 square yards / 83 square metres
- **EcoWorx Resilient** 1,000 square feet / 93 square metres
- ReWorx & Shaw Manufactured Resilient are not eligible

- **Alaska, Hawaii and U.S. Territories**

The following amounts or greater are eligible under the guarantee:

- **EcoWorx Carpet Tile + Reworx** 5,000 square yards / 4,180 square metres
- **EcoWorx Resilient** 50,000 square feet / 4,645 square metres
- Shaw Manufactured Resilient is not eligible

- **All other international locations**

The following amounts or greater are eligible under the guarantee:

- **EcoWorx / EcoWorx S Carpet Tile** 5,000 square yards / 4,180 square metres
- **EcoWorx Resilient** 50,000 square feet / 4,645 square metres
- ReWorx and Shaw Manufactured Resilient are not eligible
- Shaw will pay for the transportation cost of EcoWorx & EcoWorx S Carpet Tile and EcoWorx Resilient material back to Georgia from any international port
- Costs incurred to transport EcoWorx & EcoWorx S Carpet Tile or EcoWorx Resilient from its origin to an international port are not included as part of the Environmental Guarantee

Other Flooring Types

- To be eligible to be an externally recycled reclamation, the project must be:
 - Carpet minimum of 500 square yards
 - Shaw commercial bio-based resilient minimum of 5,000 square feet
 - Associated with a replacement order through Shaw in the same or greater quantity
 - Located in the U.S., Canada, Australia or Mexico
- Upon receipt of the reclamation project request, Shaw re[TURN] reclamation will determine the best recycling option for the material and submit a proposal for customer approval.
 - Allow up to 3 business days to receive a project proposal for approval.
 - Allow 5 business days for transportation scheduling from proposal approval date.
- The project cost will be direct billed to the existing Shaw customer account on a separate invoice.

Transportation Guidelines (All Flooring Types)

- The pick-up location should be able to accommodate a 53-foot trailer and a live load of the material.
 - Additional required services such as pup trailers, dropped trailers, etc. will be provided as necessary at additional cost. These services are available in the continental United States and Australia only.
 - Trailers must be clean of any non-flooring debris (i.e. construction waste, cardboard boxes, trash, etc.).
 - A trailer refusal fee will be applied to any project that is not available for pick-up at the scheduled time.
- Shaw will not be held liable for any non-conforming material or any charges that arise from non-conforming loads. Any additional costs or liability associated with a non-conforming load will be passed on to the customer.
- Shaw will provide a proof of recycling certificate upon project completion. The certification process may take up to 30 days from the pick-up date.
